

**SUASCO Cooperative Invasive Species Management Area  
Request for Proposals**

The Steering Committee of the SUASCO Cooperative Invasive Species Management Area has received \$4,500 from the Sudbury-Assabet-Concord Wild & Scenic River Stewardship Council (RSC) to fund one or more invasive species control projects. The Steering Committee is seeking proposals from CISMA Partner organizations for projects that would directly benefit the rivers by either eradicating/managing applicable priority species or by supporting educational outreach efforts. The watershed-wide priority species are listed in Table 1. Projects must occur within the Sudbury-Assabet-Concord watershed. The RSC works to protect the resource values of the SUASCO river, including ecology, scenery, recreation, history and literature. Please describe how your project will help to meet the RSC's objectives. We encourage proposals to include collaboration among multiple landowners, and/or recruiting and training a group of volunteers (or making use of existing volunteers), but these aspects are not required.

Proposals should include details on project objectives and methods, discussion of how the project relates to the RSC goals, a project timeline, and a detailed budget. Proposals must include a process for evaluating effectiveness of the control effort and demonstrate a capacity for long term monitoring and follow-up. Proposals should be no more than two pages plus supporting materials such as maps and letters of support.

All applications will be reviewed by a subcommittee of the SUASCO CISMA Steering Committee and discussed by the full Steering Committee at a meeting currently scheduled for September 13th, 2016, 1 pm, at the Great Meadows NWR headquarters. All applicants are encouraged to attend this meeting, but attendance is not required. The Steering Committee will strive to allocate funding by consensus. However, if a vote is required, Steering Committee members whose organizations have applied for funding *will not be able to* participate in discussions and decisions regarding allocation of funds.
