- Knotweed biocontrol Open comment period just closed, link will be available in next newsletter to read public comments

#### **CISMA Small Grant Proposals**

- Five applicants, \$4,837 available
  - Natick Marianne Iarossi present for questions. Requests \$2,000 to develop management plan for controlling invasives and ED species in Hunnewell Town Forest, supported by Native Plant Trust
  - Ashland Rob St. Germain present for questions. Requests \$2,000 to map knotweed, barberry and bittersweet along with manual removal in high priority Ashland Town

    Forest
  - Stow Conservation Trust John Sangermano present for questions. Requests \$1550 to plan and control invasives at Leggett Parcel
  - Wayland \$1,400 for purchase of native seed to restore disturbed area at Lower Snake Brook Conservation.
  - Hopkinton \$500 for bittersweet control mechanically at Whitehall Reservoir, then follow up with management plan
- SC approved \$500 for Hopkinton, \$1000 for Ashland, \$2000 for Natick and \$1000 for Stow. Stow and Hopkinton will be asked to attend the EDC Spring Management workshop

- SC approves a restoration and pollinator theme, speakers to discuss seed mixes and other restoration strategies
- Merge Metrowest Conservation Alliance and CISMA spring meeting
